IN ANY CASE I WILL HAVE TO DRIVE TO EITHER HEILBRONN OR SCHWAIGERN WHICH ARE ONLY A FEW KILOMETERS APART FOR EACH INTERVIEW BETWEEN HIM AND FRAU E. THEREFORE I CAN TAKE O'CONNOR WITH ME IN MY CAR.

THE PREPARATION OF THE MANUSCRIPT IN WINNENDEN WILL MEAN VERY LITTLE TIME LOSS FOR ME.

AND THIRDLY - IF YOU SHOULD FEEL IT NECESSARY TO CONCERN YOURSELF WITH THE MATTER, WINNENDEN IS THE CORRECT PLACE ISN'T IT.

YOU SHOULD ALSO CONSIDER WHETHER I MUST TAKE CARE OF LODGING FOR OUR FRIEND HERE AND FROM WHEN TO WHEN.

I ALSO REQUEST DEFINITIVE ADVICE WHETHER THE TRANSLATION OF THE PAGES OF THE DIARY WHICH HAVE ALREADY APPEARED IN ENGLISH MUST BE MADE.

FOR THE PERIOD 15-30 AUGUST WE HAVE MADE RESERVATIONS IN THE GASTHAUS POELT, FELDAFING. IF NECESSARY WE CAN MEET THERE.

IN ORDER TO FAMILIARIZE MYSELF WITH THE THINKING OF E'MANN, I HAVE GOTTEN HANS GRIMM'S BOOK /'WARUM-WOHER - ABER WOHN'/' WHICH YOU ARE SURE TO OWN. I AM GETTING OTHER MATERIAL.

3. A POSSIBLE REFERENCE TO THE O'CONNOR MENTIONED IN THE ABOVE LETTER WAS MADE BY ALIAS RUFF TO [redacted] ON 13 JULY 61. WITHOUT REFERENCE TO ANYTHING IN PARTICULAR, JUFF MENTIONED THAT ONE, FNU O'CONNOR, AN AMERICAN COMMUNIST WHO USED TO BE IN EAST GERMANY, IS PRESENTLY IN SOUTH AMERICA.

4. IF OUR SUSPICION, EXPRESSED IN REFERENCE B., THAT RECHENBERG IS WORKING FOR UPHILL IS CORRECT, THE ABOVE LETTER IS OBVIOUSLY CONNECTED WITH ALIAS WINTERSTEIN'S INFORMATION ON PLANS FOR ADDITIONAL PUBLICATION OF THE EICHMANN MEMOIRS AND RECHENBERG WOULD BE A GOOD CANDIDATE FOR THE SERVATIUS MIDDLE-MAN MENTIONED IN MUNI 5678. O'CONNOR'S ROLE, IF HE IS RUFF'S 'AMERICAN COMMUNIST', RAISES THE HIGHLY SPECULATIVE POSSIBILITY THAT THE KANNICHT-RECHENBERG COMPLEX IS AN EASTERN EFFORT.

5. WE WILL KEEP YOU ADVISED OF ANY FURTHER DEVELOPMENTS EITHER IN THE CORRESPONDENCE OR FROM ALIAS RUFF. IN THE MEANTIME WE WOULD APPRECIATE HEADQUARTERS' COMMENTS AND IF POSSIBLE, AN IDENTIFICATION OF AND ADDITIONAL INFORMATION ON O'CONNOR.
