REFERENCE A, COMMENTING ON MLB'S REQUEST, REF B, TO BE ADVISED OF THE SIGNIFICANCE OF THE REPORTING ON THE MANY INTERESTS AND CONTACTS OF HANS RECHENBERG, INDICATED THAT MOST OF THE PERSONS REPORTED ON WERE OF SOME INTEREST TO KUBARK AND THAT HEADQUARTERS WISHED TO CONTINUE TO RECEIVE THIS REPORTING FOR A TIME IN ORDER TO BE ABLE TO PROVIDE A MORE SIGNIFICANT EVALUATION. SINCE THAT TIME, WE HAVE RECEIVED REFS. C, D, E, F AND G, AMONG OTHER CORRESPONDENCE, PROVIDING DETAILED AND VOLUMINOUS INTERCEPT CORRESPONDENCE CONCERNING SUBJECTS CONTACTS.</p> <p>2. A CAREFUL READING OF THIS LATEST CORRESPONDENCE LEADS TO THE CONCLUSION DRAWN BEFORE, I.E. THAT IT REFERS TO PERSONS OF SOME INTEREST, BUT DOES NOT APPEAR TO CONTAIN INFORMATION OF SIGNIFICANCE TO KUBARK CONCERNING THEM. WE REQUEST, THEREFORE, THAT IN FUTURE THE INTERCEPT CORRESPONDENCE CONCERNING SUBJECT NOT BE FORWARDED TO HEADQUARTERS. SHOULD YOU CHOOSE TO CONTINUE TO PURSUE THIS CASE FOR YOUR OWN PURPOSES, E.G. TO IDENTIFY MORE PRECISELY SUBJECTS RELATIONSHIP TO UPHILL, A RESUME OF YOUR FINDINGS WOULD BE SUFFICIENT FOR HEADQUARTERS PURPOSES.</p>
