RECHENBERG, HANS [] IN DISCUSSING GENOUD, WE ASKED WHO HIS FRIENDS IN GERMANY WERE AND CARAVEL CAME UP WITH THE NAME HANS RECHENBERG [] CARAVEL HAS MET HIM THREE OR FOUR TIMES IN THE PAST 12 YEARS, ALWAYS IN THE PRESENCE OF GENOUD AND THOUGH THEY NEVER DISCUSSED POLITICS, CARAVEL GOT THE IMPRESSION THAT RECHENBERG WAS A "RIGHT WING RADICAL". THE LAST MEETING WAS IN THE FALL OF 1962 IN CARAVEL'S OFFICE. THERE WAS NO DISCUSSION OF CARAVEL'S BUSINESS OF THE ALGERIAN SUPPORT PROGRAM AND RECHENBERG HAS NEVER CALLED CARAVEL UP. HENCE THE STATEMENT IN PARAGRAPH 4 OF REFERENCE MAY BE WRONG. SINCE CARAVEL CONSIDERS GENOUD AN UPHILL AGENT, HE ALSO ASSUMES THAT RECHENBERG IS ONE. CARAVEL HAS DISCUSSED SURVEILLANCE EQUIPMENT WITH GENOUD, BUT ONLY IN TERMS OF TELLING HIM THAT IT WOULD HAVE TO BE CONSTRUCTED SPECIALLY BY AN ELECTRIC FIRM. SEE DOC.
