1. RECHENBERG HIGH LEVEL CATIDE AGENT, PROBABLY HAS STATUS ROUGHLY EQUIVALENT KUBARK CAREER AGENT. MLB MAINTAINED UNILATERAL CALLIKAK COVERAGE HIS MUNICH OFFICE, ARABO AFRIKA GESELLSCHAFT MBH, BEICHSTR. 8 DURING 61 AND 62. HIS ACTIVITIES COMPLICATED AND FAR REACHING, AND WITHOUT GOING INTO DETAIL HERE SUGGEST BONN REVIEW FILE WHICH PROBABLY TRANSFERRED FROM FRAN. UNION INTEREST POSSIBLY BASED R'S ACTIVITIES AFRICA.
2. FOR OBVIOUS REASONS [ ] REQUEST SHOULD NOT BE HONORED. SIMPLE EXPLANATION COULD BE THAT RECHENBERG WELL KNOWN PERSONALITY IN SMALL TOWN MAKING COVERAGE TOO RISKY. THIS TRUE AND IS REASON WHY MLB COVERED MUNICH OFFICE AND NOT BAD TOELZ HOME.
3. ALTHOUGH [ ] REQUEST AND OUR PRIOR INTEREST MIGHT WELL HAVE BEEN NOTED BY CALLIKAK FRAN OR MUNI, AND THE SITUATION ALREADY RESOLVED THRU LATERAL STATION TRAFFIC, HQS SOMEWHAT CONCERNED THAT CALLIKAK COVERAGE CAN BE INSTITUTED ON BEHALF FOREIGN LIAISON SERVICE PRIOR REVIEWING CONSIDERABLE INFO WHICH SHOULD BE AVAILABLE STATION
