Separate cover attachment A is the basic correspondence between CAMEN and one of the principals in the <input type="checkbox"/> <input type="checkbox"/> case. Attachment B is a political analysis, presumably written by this principal about December 1964; attachment C is a record of a press conference involving the imprisonment of another individual mentioned in the case (see paragraph 3 of reference).</p> <p>4.
