REFERENCE(S)	<p>A. Book Dispatch 1009 B. Book Dispatch 1280</p> <p>1. As result of the response to Book Dispatch 1009, the Headquarters collection of Soviet manuscript and typescript has been substantially augmented by a good deal of material valuable to the general purposes outlined in the dispatch. It is considered worthwhile to extend this requirement, both to continue the expansion of this collection and to give it a better geographic balance by participation of those Stations and Bases which have not yet responded. The requirement in Book Dispatch 1009 is therefore extended through calendar year 1960.</p> <p>2. With regard to paragraph 2c of the dispatch, Headquarters desires to reemphasize the importance of acquiring certain data on Soviet-owned machines for which specimens are unobtainable. Such information as make, model, and language of a typewriter; its user or purchaser; and particularly its location within an installation, are obviously of great potential value, even in the absence of an actual sample of its type-face.</p> <p>3. Addressees are urged to exploit all sources for meeting the requirements of the dispatch. In particular, it is felt that a broader selection of material in Cyrillic might be available in the form of official communications (aides-memoire, etc.) addressed to the host country. The assistance of liaison services therefore should be requested, where appropriate and where security considerations are favorable.</p> <p>4. Addressees are requested to forward materials to the attention of Chief, SR, slugged REDWOOD/LCIMPROVE/AECORONA, with reference to this dispatch. KURIOT interests will be fully provided for by REDWOOD.</p> <p>5. Delinquent addressees are reminded of the 31 December 1959 reporting date set in Book Dispatch 1280.</p> <p>6.
