SUBJECT: Disposal of Calesa I

1. Drove to Wiesbaden to see Calesa I on 27 August 1947 for the purpose of executing final payment and disposal of him as an agent associated to the organization.

2. In confronting Calesa I for what is assumed the last time as an official relation, or act, Calesa I evidently had prepared himself with only a few questions in regard to his affiliations with us. He asked, for example, what would become of his uncle and aunt who live in the Soviet Sector and his mother, living in the U.S. Sector of Berlin respectively, should the Soviets happen to seek him for not appearing, as he supposedly promised, about 16 September 1947. [] parried with him on this subject as he did on other problems that Calesa attempted to bring up. Calesa also wanted intervention with MG, in his behalf, so that he might receive certain privileges, assumingly promised him by []. In respect to this, Calesa was told that he should invest some initiative in bettering his future status instead of straddling the roads in the U.S. Zone between Wiesbaden and Heidelberg. While talking to Calesa about his supposed problems and plans, attention was firmly brought forth that he is not to return to Berlin and never to approach any member of the organization in public or otherwise just to be a nuisance on something he can work out or solve for himself.

3. As a further binding obligation, to a certain extent, that he will keep secret his work for U.S., whether in the intelligence field or dealings concerning aid given him by MG authorities, Calesa I read thoroughly and understood clearly before affixing his signature to the "Quit Claim for Agents Under Formal Contract" forms in the English and German versions. Upon signing the forms Calesa was asked if he had been treated fairly for his services to which he answered in the affirmative.

4. As final payment due him, Calesa received and signed a receipt for 19500 RM. He was given to understand that this is a definitely final official act with our organization.

5. He iterated that one of his plans is to journey to South America, preferably Argentina, where he expected to establish himself. To this [] answered that we have nothing more to do with him and that any future responsibilities were of his own choosing.

6. The case of Galea I is considered closed. However, occasional checkups should and will be made to observe his conduct and behavior to avoid embarrassment with MG officials who have been cooperative in many instances.

7. Copies of travel orders emanating from Berlin were picked up so that such papers would not be in his possession as evidence of his recent visit to Berlin.
