2. HQS HAS VOLUMINOUS TRACES ON OTTO ERNST REMER BORN 18 AUG 1912 IN NEUBRANDENBURG GERMANY. ENTERED GERMAN ARMY 1933. WAS MAJOR COMMANDING BERLIN GUARDS REGIMENT AT TIME 20 JULY 1944 PLOT TO ASSASSINATE HITLER. HIS TELEPHONE TALK WITH HITLER AFTER BOMB EXPLOSION CONVINCED HIM ARREST 20 JULY PLOTTERS AND HELPED HITLER SMASH PLOT. IN GRATITUDE HITLER IMMEDIATELY PROMOTED REMER TO GENERAL MAJOR. DETAILS REMERS ROLE 20 JULY PLOT AVAILABLE IN ANY OVERT BOOK DEALING WITH GERMANY IN WW II. AFTER WAR REMER BECAME DEPUTY CHAIRMAN NEO-NAZI SOCIALIST REICH PARTY WHICH BANNED BY BONN GOVERNMENT 1952. HE SENTENCED JAIL MARCH 1953 FOR BLANDERING 20 JULY PLOTTERS. EVADED IMPRISONMENT WHEN HE FLED TO EGYPT AND OFFERED ACT MILITARY INSTRUCTOR EGYPTIAN ARMY. RETURNED WEST GERMANY 1954 AFTER AMNESTY.
