SUMMARY OF INFORMATION <p>1. (C) Information on file, date not available, indicates that Franz RIEDWEG, born 10 April 1907 in LUZERN, Switzerland, residing at Lerchenfeldstrasse 9, MUNICH, was married to Sibylle nee von Blomberg, and had one child born in June 1943. HIS wife had completed several missions as a courier on behalf of the GIS (German Intelligence Service), and was wanted by the Swiss Government, not further clarified. SUBJECT allegedly went to SD (Sicherheitdienst Security Service) where HE acted as Obersturmbahnfuhrer (Lt. Colonel) at MONTBELLIARD; edited SS periodical "Germanische Gemeinschaft"; HE was the Liaison Officer III SS Panzer Corps in August 1944. (UNEVALUATED)</p> <p>2. (C) Additional information, dates not available, indicates that one Dr. Franz Riedweg, not further identified, was an SS Obergruppenfuhrer and one of the Chiefs of the German SD in June 1942. Riedweg was Chief of Intelligence and Spionageabwehr (counterespionage) at the Gestapositz in the Prinz Adalbrechtstrasse, BERLIN, not further clarified. (UNEVALUATED) "It cannot be determined from our files if the above information pertains to the SUBJECT of your request, however, the information is furnished as possibly identical.
