- 3) DURING 30'S ROCHOLL EMPLOYED AMERICAN CONSULATE BERLIN AND LATER BECAME STAFF EMPLOYEE IN UNION FOR THE FAR EAST.
- 4) SUBJ ALSO EMPLOYED IN REICH ECONOMIC MINISTRY (DATES UNK). IT ASSUMED HE SERVED IN GERMAN ARMY DURING WWII.

1) SUBJ IS MEMBER "GERMAN-CHINA FRIENDSHIP SOCIETY" AND ON ADVISORY COUNCIL. THERE CONSIDERABLE EVIDENCE TO INDICATE HE HAS ENDEAVOURED NEUTRALIZE RADICAL INFLUENCE OF CHAIRMAN OF SOCIETY, WOLF SCHENKE [] , FORMER HITLER YOUTH LEADER.

2) SUBJ HAS GOOD CONNECTIONS CHINESE FIRMS (PRESUMABLY HONG KONG); ASSUMED HE SEEKS TO DEVELOP PERSONAL CONTACTS WITH MEMBERS GERMAN-CHINA SOCIETY TO FURTHER BUSINESS AIMS.
