

6. EARLY HISTORY: Subject was an excellent student. He studied law in MUNICH and ERLANGEN and became judge first in BAMBERG and later in NUERNBERG. Subject joined the Wehrmacht in 1936 and became judge at the combined Army, Air Force and Navy Tribunal in BERLIN. In 1937 Subject became president of the Senate of the Reichskriegsgerichtshof.

7. CASE HISTORY: Supreme judge in the R/K in the case against Mildrid HARNACK and Erika von BROCKDORF. Subject presided in several other cases.

8. PRESENT ACTIVITIES: Subject was a witness in the NUERNBERG Trial of Generals RENDULIC and FELMY and other Generals of the Russian Front. In January 1948 Subject was released to the French authorities as a witness in the trial against Admiral BASTIAN in RASTATT, French Zone.

9. REMARKS: Subject may have been released and gone to KEHLHEIM where his sister resides.

7. CASE HISTORY: Subject was one of the judges in the R/K; among other cases he passed verdict in the cases of Harro and Libertas SCHULZE-BOYSEN, Arvid HARNACK, von SCHELIHA, SCHUMACHER, GRAUDENZ and COPPI. *Rote Kapelle case.*
