EX LUFTWAFFE ACE, OBERST RUDEL EX PATRIATE RESIDING IN ARGENTINA PRESUMABLY IN OR NEAR BUENOS AIRES RECENTLY VISITED WESTERN GERMANY AND CONTACTED SEVERAL GROUPS FORMER WEHRMACHT OFFICERS CORPS EXPOUNDING THAT GERMANS SHOULD NOT LIFT A FINGER AGAINST SOVIET CONQUEST OF GERMANY AND EUROPE AS IN TIME GERMANS COULD DO BETTER WITH RUSSIANS THAN WITH WEST. RUDEL ALSO VISITED SWITZERLAND SPEAKING TO VARIOUS PEOPLE THERE. HE DEPARTED ABOUT TWO WEEKS AGO TO RETURN ARGENTINA. CONTROLLED GERMAN EX NAVAL SOURCE WITH WHOM RUDEL ALSO SPOKE IS VERY SUSPICIOUS THAT LATTER IS IN COMMUNIST PAY. RUDEL ADVISED HIM THAT HE HAD BROKEN OFF RELATIONSHIP WITH LUFTWAFFE GENERAL GALLAND AND OBERST BAUMBACH ALSO IN ARGENTINA AS BOTH WOULD LIKE TO GET INTO UNIFORM AGAIN AS ARGENTINE INDUSTRY OFFERED NO POSSIBILITIES FOR AVIATION TECHNICAL DEVELOPMENT. SUGGEST U. S. REPRESENTATIVES BUENOS AIRES DISCREETLY TAKE UP WITH ARGENTINE OFFICIALS RUDEL'S HIGHLY SUSPICIOUS PRO-COMMUNIST TALKS TO GERMAN MILITARY CIRCLES AND ATTEMPT ESTABLISH IF HE IS IN SOVIET SERVICE. RUDEL APPARENTLY HAD FINANCIAL MEANS. EVALUATE B2.
