TRACES

There are numerous traces on a fnu RUDEL (probably Hans Ulrich RUDEL), former Luftwaffe ace now living in Argentina who has traveled to West Germany where he has contacted groups of former Wehrmacht officers and has made pro-Russian statements. He sounds like the type, but no evidence that he has lived in Germany since the war.

BfV reports on the planned establishment of a "Roof Organization for Nationalistic Youth Organizations" by a fnu RUDEL. BfV ~~is~~ requests that RUDEL's plans and contact men in the Fed Rep be kept under observation.

DTLINEN visitor Horst HAMANN, Dresden, reported he working for KGU Ost, Untergruppe Stumpo" whose chief allegedly fnu RUDEL, former Air Force officer, and fnu REICH. HAMANN ~~is~~ astounded when told this not part of DTLINEN. H says group has weapons, ammo, W/T, uniforms. Traces and comments requested.

TRACE IN SKORZENY (C...) file on fnu RUDL, probably Luftwaffe fellow. Nothing current. Indicates he personal friend of S.

SEVERAL CARDS ON MICROFILM ON RUDL'S, FORMER MEMBERS OF SIPO ABT III. NOT CHECKED.

Among his G.I.S. contacts, S. reported on an SS Untersturmfuehrer RUDL. Former member of Abt III Brussels, then sent to Ost Lille where he had a special mission in connection with the Wehrmacht. Cize 26, speaks French & German.
