SUBJECT : Control and Compromise Indicators in Message No.  
7 from CAMBARO/2

1. The subject message contains the following indicators:
  - a. In the overt text the date is written 22./X.54.g. in order to show freedom from control.
  - b. The covert message is signed "ARTUR" misspelled correctly in order to show freedom from control.
  - c. The period after "NR" in the covert text is omitted in order to show freedom from control.
  - d. At the conclusion of the covert text the date is written to the right of the signature and in the proper form (23/X 54.) in order to show freedom from control.
  - e. The first word of the third sentence of the covert text begins with "A" in order to show freedom from control.
  - f. The final period of the last sentence of the covert text is omitted in order to show freedom from control.
2. No control and compromise indicators applicable to this message were omitted.

MESSAGE NO. 7 (FROM CAMBARO 2)

(See attached Memo for control and compromise indicators)

Continuation (of Message Nr. 6) (THE FOLLOWING ARE) SIX CONTROL AND COMPROMISE INDICATORS FOR (AECOB 4'S) S/W MESSAGES. IN THE OVERT TEXT: THE SECOND OR THE THIRD SENTENCE MUST CONTAIN FIVE WORDS. IN THE COVERT TEXT THE SECOND OR THIRD SENTENCE MUST CONTAIN THE SYLLABLE "CI" (KEY INDICATOR). UPON RECEIVING THE CHALLENGE WORDS "LAIKRAKSTS" (NEWSPAPER) OR "SPEJAS" (ABILITY) HE WILL REPLY NONSENSICALLY. UPON RECEIVING THE CHALLENGE "ATTALUMS" (DISTANCE) HE WILL REPLY WITH A DIFFERENT LOCATION OR DIRECTION. IN THE EVENT A GENUINE QUESTION IS DESIRED, THESE WORDS WILL BE USED INSTEAD: "AVIZE" (NEWSPAPER) "DOTIRAS" (ABILITY) "DISTANCE" (DISTANCE) AND THE SIGNATURE (SPCDRA) WILL BE MISSPELLED. I WILL SHORTLY BEGIN TRAINING (AECOB 4) IN W/T. SEND ME A SIGNAL PLAN FOR HIS USE AND THE SCHEDULES AND FREQUENCIES OF THE GERMAN TRAINING STATION. AFTER RETURNING FROM THE EXFILTRATION ATTEMPT (CAMUSO 2) WAS LEFT ONLY WITH THE REMAINDER OF HIS EQUIPMENT WHICH CONSISTS OF A RECEIVER AND HIS INTERNAL S/W INK NO. 2. I GAVE HIM MY SMALL SIGNAL-PLAN (LTWANOP), MY DECODE PAD NO. 67300 AND MY ENCODE PAD NO. 93335. I ALSO GAVE HIM MY HAMBURG ADDRESS-- IF THIS IS NOT SUITABLE FOR HIS USE, NOTIFY HIM AND GIVE HIM A NEW ADDRESS. I ALSO GAVE HIM 10,000 RUBLES. I MADE A COPY OF MY LTWANOP SIGNAL PLAN FOR NOVEMBER IN ORDER THAT NO MISUNDERSTANDINGS OCCUR. SHOULD I CONTINUE CONTACT WITH (CAMUSO 2)? SINCE I HAVE GIVEN AWAY TWO OF MY LETTER-DROP ADDRESSES, SEND ME ONE TO REPLACE THEM. BECAUSE OF THE NOVEMBER CELEBRATION, I WILL DISAPPEAR FROM RIGA. I WILL BE AT THE LOCATION ALREADY KNOWN TO YOU AT PURE. FOR THE PRESENT, UNTIL I RECEIVE CONFIRMATION OF THE RECEIPT OF THESE LETTERS (MESSAGES 6 AND 7) I WILL LISTEN ON THE ASTERICK DATES ACCORDING TO BOTH SIGNAL PLANS. IN GENERAL, DURING THE WINTER I DON'T INTEND TO COME TO RIGA EXCEPT WHEN ABSOLUTELY NECESSARY. IMMEDIATELY PRIOR TO EXFILTRATION I LEFT THE FOLLOWING RECOGNITION SIGNALS WITH AECOB 5 "DOES PETROVES WORK

HERE?" HE WILL REPLY, "NO, HE LIVES ON GAUJAS IELA". I NOW LEAVE HIM (AECOB 5) AND DO NOT INTEND TO RECONTACT HIM BECAUSE IN CONNECTION WITH THE PREPARATIONS FOR EXFILTRATION AND DUE TO MY LATER RETURN, HE HAS BECOME TOO WITTING. HE IS A GOOD FELLOW WHO CAN BE UTILIZED BY SOMEONE ELSE. THERE IS ABSOLUTELY NO QUESTION THAT HE WILL RECEIVE AND SUPPORT ANYONE. FROM NOW ON I WILL BE LOCATED AT SVERDLOVA IELA 7-15, RIGA, C/O ERIKA ZVIRGZDINS. IN CONNECTION WITH MY UNSUCCESSFUL EXFILTRATION AND THE UNEXPECTED RETURN TO OPERATIONAL ACTIVITY, I HAVE LOST TRACK OF THE CONTENT OF OUR MESSAGES, THEREFORE, GIVE ME QUESTIONS, CRITICISMS AND DIRECTIONS FOR FUTURE ACTIVITY. IN CONNECTION WITH MY FINANCES I MUST REPORT THAT AFTER OUR RETURN I GAVE (CAMUSO 2) 10,000 MORE RUBLES, WHICH TOGETHER WITH THE PREVIOUS AMOUNTS MAKES A TOTAL OF 28,000 RUBLES. I HAVE EXPENDED 15,000 RUBLES MYSELF. I HAVE A BALANCE OF 26,000 RUBLES LEFT. DO YOU APPROVE OF MY HOUSEKEEPING (IN LATVIA)?
