The records of the Department of Motor Vehicles, as furnished by K. Robertson to Investigative Clerk Thomas I. Mc Guinness on March 2, 1961, reflected that a 1960 New York license plate KR - 997 had been issued to a brown and beige 1959 Ford in the name of Lucia Rupners, 2902 Courtelyou Road, Brooklyn, New York. It reflected that she was born on March 14, 1907 and her present place of employment was the Jewish Hospital, Prospect Place, Brooklyn, New York. There was no current or expired driver's license issued however in the name of Lucija or Lucia Rupners.

The files of the Credit Bureau of Greater New York, as checked by Special Agent Walter C. Zink on February 20, 1961, contained no record concerning Pauls or Lucija Rupners.

On February 23, 1961, Sidney A. Davis, Assistant Chief, Records Administration and Information Section, Immigration and Naturalization Service, 20 West Broadway, New York City, advised Special Agent William F. Martin that he had no record concerning Pauls or Lucija Rupners.

On April 19, 1961, Mrs. Karlis Gruntals, Superintendent, Apartment A9, 2902 Courtelyou Road, Brooklyn, New York, who is of Latvian origin, was interviewed with the assistance of her daughter-in-law, DZIDRA OLIVENCIA, Apartment A10, 2902 Courtelyou Road, Brooklyn, New York.

Mrs. Grintals and Mrs. Olivencia stated that Pauls and Lucija Rupners currently reside in Apartment B4 and have been at this address for more than five years. The superintendent at this address prior to Mrs. Grintals was also of Latvian origin.

Mrs. Grintals and Mrs. Olivencia stated that Lucija Rupners is a nurse in some Jewish hospital in Brooklyn, Pauls Rupners is unemployed. He is a sickly man and had a heart attack last year. He usually drives every day to the hospital to pick Mrs. Rupners up in their car.

Mrs. Grintals and Mrs. Olivencia stated the Rupners are good tenants. They are quiet people and do not appear to have many friends or visitors. Mrs. Grintals and Mrs. Olivencia stated that they knew nothing derogatory concerning them whatever. They were unaware of any details of their background.
