SUBJECT : Albins SIETINSONS
Internal Security

1. The following information is provided in response to your request, Bureau Memorandum, 6 June 1961, File Number 105-95861, Subject: Albins SIETINSONS, that this office advise you if we have any present relationship with the Subject and, if not, why our interviews were terminated in December 1954.

2. As was stated in Paragraph 4c of CSCI 3/762,805, 17 January 1961, Subject: Velta RUPNERS, et al, Albins SIETINSONS agreed to the proposal of this office that his mail channel with Ilmars RUPNERS in Latvia be diverted for its utilization by this office to receive clandestine communications from RUPNERS. SIETINSONS further agreed to our proposal that the mail from RUPNERS would be forwarded from his cut-out in Germany, Frau DOSER, to an address other than SIETINSONS' home address. Under the guidance of a staff employee of this office, SIETINSONS wrote a letter to Frau DOSER in which he instructed her in the use of the new address she was to use in forwarding mail for SIETINSONS from RUPNERS. Frau DOSER apparently understood these instructions and, early in 1955, she forwarded a letter from RUPNERS to the new address. Consequently, there did not appear to be any need for further contact with SIETINSONS and there has been none since December 1954 with the exception of a contact by mail between SIETINSONS and a contact of this office that was initiated by SIETINSONS via an accommodation address. Even this contact was terminated in the summer of 1955.

3. During the interviews with SIETINSONS by staff members of CIA, SIETINSONS appeared to be cooperative and was seemingly appreciative of the interest by this office in his homeland since he realized he was in no position personally to assist his fellow countrymen.
