FRANKFURTER ALLGEMEINE AND SUEDEDEUTSCHE ZEITUNG ALSO CARRY ARTICLES ON 19, 20 AND 21 FEB CONCERNING TRANSFER OF THEO SAEVECKE [ ] FROM SG TO BKA WIESBADEN AND INSTITUTION OF DISCIPLINARY ACTION BASED ON FACT HE CONCEALED SD BACKGROUND. FRANKFURTER ALLGEMEINE 23 FEB CARRIES ARTICLE INDICATING EAST GERM PUBLICITY THIS CASE.

2. BACKGROUND OF SAEVECKE DISCUSSED WITH AELADLE BY UPHILL BEPS WITHOUT POSITIVE RESULTS (SEE TAPE 14 PAGES 15-18). BRIEF SUMMARY OUR FILE ON SAEVECKE REVIEWED WITH AELADLE 5 FEB. AELADLE STATED BACKGROUND AND BIO DATA NOT FAMILIAR. COMMENTED HOWEVER THAT CIRCUMSTANCES HIS CLEARANCE OF WAR CRIMES CHARGES IN 46 WITH HIS ASSISTANCE SHOULD BE EXAMINED IN RELATION TO CASE KNOWN AELADLE OF KGB AGENT WHO SUSPENDED FOR FASCIST ACTIVITY BUT SUBSEQUENTLY CLEARED AND REINSTATED THROUGH ASSISTANCE OF ANOTHER KGB AGENT WHO HAD POSITION WITH POLICE, DENAZIFICATION COURT, OR SIMILAR ORGANIZATION.
