1. A look at our files reveals no action taken on MGK-7060, or on our end of the steps suggested in MAV-W-3201. We are at a loss to explain why nothing has been forwarded on this most interesting and important case in the past year, but presume it is the usual complaint "shortage of people". We have a couple of reasonable possibilities to run down some of the desired information, viz. through CIC and through CARAVEL. As you know, CARAVEL is working feverishly on the problem of transferring his office and is shouldering most of the policy load in connection with his particular area of activity, so we don't know how much help we can expect from him immediately. Nevertheless, it is a problem we shall enjoy working on and we will of course forward any information we turn up to Salzburg.

2. We would also like to ask Salzburg to provide us with any information they come across which would help us in investigating the German end of this complex. They should of course indicate information on which we should not act because of the danger of such action on their nascent operation.
