PERTINENT INFORMATION

THE FOLLOWING INFORMATION IS QUOTED VERBATIM

A. 2.
 The policy and secrets of Amt VI are in the hands of a group of associates of SHELLENBERG, some of whose names are known but whose functions are not precisely defined.

B. 4. The Amtschef, Brigadefuehrer SHELLENBERG, has a central office of adjutants and personal assistants which constitutes the directorate of the Amt. In addition to SHELLENBERG's adjutants and advisers Staf. Knochen, formerly BdS in Paris, has recently been appointed to a new post as Inspector of Amt VI. The significance of this appointment is not known but it must be assumed that Knochen ranks after SHELLENBERG in Amt VI.

5. a) Steimle was formerly head of Amt VI B and is still sometimes referred to as Gruppenleiter VI B. He is responsible to SHELLENBERG for all espionage in Western Europe, both of the Mil. Amt and of Amt VI itself. He was also - at least until Knochen's appointment - SHELLENBERG's deputy.

b) Staf Sandberger is the chief administrative officer both of Amt VI and the Mil. Amt, and with SHELLENBERG, Steimle and Knochen constitutes the Central Directorate of Amt VI.

c) Stufaf. Schmitz is SHELLENBERG's personal assistant, particularly in questions of personnel.

d) Stufaf. Eggen is economic adviser to Amt VI in general and to SHELLENBERG personally. He is reported to have useful and mysterious contacts in the commercial world outside Germany.

e) Fraulein Schinkel, SHELLENBERG's personal secretary, is reported to have considerable knowledge and influence.

f) Stufaf. Frank and Stufaf. Diedrich have also been mentioned as part of SHELLENBERG's bureau of personal advisers, but no further details are known about their work.
