FOLLOWING IS CABLED SUMMARY OF SCHELLENBERG INTERROGATION: A). SCOOPS SECURED BY KARL HEINZ KRAEMER (SYMBOLS JOSEFINE AND HASSO) WERE MESSAGES OF INTENDED ARNHEM LANDING AS WELL AS IMPENDING ATTACK ON PHILIPPINES. KRAEMER COOPERATED CLOSELY WITH ONODERRA JAPANESE MILITARY ATTACHE IN STOCKHOLM. B). O'RYAN IN BERLIN HELPED SCHELLENBERG IN PARACHUTING 2 IRISHMEN OVER IRELAND. RIBBENTROP AND VEESEMAYER WHO WERE JUST PREPARING REVOLT IN IRELAND WERE FURIOUS OWING TO THIS INTERFERENCE WITH THEIR PLANS. C). LOBMAYER'S FREE AUSTRIAN MOVEMENT IN LISBON WAS FINANCED BY SCHELLENBERG VIA BREISKY. LOBMAYER WAS HOWEVER UNCONSCIOUS OF IT. D). FOLLOWING ARE SCHELLENBERG'S GUESSES RE WHEREABOUTS OF RSHA MEMBERS. MUELLER OF AMT IV IN BERLIN JAHNKE NEAR BAEFWALDE POMMERANIA, VI IN KITZBUHEL, SCHMIT SURELY CAPTURED NEAR FLENSBURG, EGEN IN SOUTH NEAR MARQUARDSTEIN WHERE HE WAS TO PROTECT SCHELLENBERG'S WIFE AFTER ESCORTING AMERICAN VANNAMANN OVER FRONTIER, SCHMIED ON PROPERTY IN STYRIA, KNOCHEN IN VIENNA OR MUNICH, STEINLE IN MARQUARDSTEIN, BICKLER IN CONSTANCE. E). SCHELLENBERG DEALT IN DETAIL WITH QUESTION RE NON-EXISTING GERMAN POST DEFEAT PLANS. HE ALSO MADE STATEMENTS ON DECEPTION AND RELATIONS BETWEEN AMT VI AND I.G. FARSEN.
