PERTINENT INFORMATION:

- pg. 2 "...MSBA 602, 2/05/49. Subject named by Prince Nicolai STOURDZA in visit to our [] station as working for Americans in Salzburg along with Francois PLESKY, and Ernst SCHLANDT (probably id/w PLESKY and SCHLANDT in MGLA 171). These individuals are members of a group managed by Herbert MALNER and BLOSCHWING who are engaged in collecting information on Rumania..."
- pg. 3 "...MAVA 942, dated 25 February 1948, continues further clarification of FLORESCU's position. The source for this information was SS-Hatuf Ernst SCHLANDT, once an associate of FLORESCU's in RSHA VI E 7 and apparently the individual referred to in MGLA 171, para 6. According to SCHLANDT, Dr. Valter FLORESCU is an alias used by Dr. Walter VOLLBERT, also spelled FOLBERT and FOLBERTH. VOLLBERT was born in Medias, Rumania..."
- pg. 4 "...MAV-W 542, dated 29 April 1948, suggested that since AUNER, SCHLANDT, and VOLLBERT have been reported as members of the Waldmann group (MSBA-602 and FRAN-258), it would appear that AUNER and/or VOLLBERT are penetrating the Waldmann group for the RIS..."
- pg. 6 "...SCHLANDT, fmu (also spelled SCHLANT)
The following traces are available under the name SS-Hatuf SCHLANDT. LSX 42, 8/7/45, KLATT Interrogation. Subject is Volksdeutscher from Rumania. Leiter of MdK, Prague in Vienna, located in the firm 'Burgenlaendische Kreide A.G.' Directly subordinate to Captain KLAUSNITZER. Was in Ischl, Austria early in 1945.
XX-84, 2/8/46. Subject head of an advanced post in Vienna of the Prague office of Gruppe VIZ of the RSHA.
XX-10798, 2/11/46. In Amt VI Z Ost in KdM, Prague as liaison officer, July 1944..."
