<p>1. We have not made any positive progress in identifying "HUELSE" of the SAUTER papers but are inclined toward the idea that it is a pseudonym, rather than a true name. We have speculated that it may have been the cover name used by SAUTER himself. The basis for this speculation is the meaning of the German word "HUELSE" which is a covering or hull (such as a pea-pod or cigarette paper) and that SAUTER was the collection point for all the reports of the sub-agents, i.e., he was the "HUELSE" where all the reports were collected and analyzed. In studying the SAUTER papers, it appears that "HUELSE" was more of an analyst who came to certain conclusions based on sub-agent reports, rather than a sub-agent collecting data. "HUELSE" also is signed to reports covering all geographical areas as opposed to other sub-agents who apparently operated in certain areas which, in turn, points to the central collection office. We have found only one or two reports, one signed "AS" and another "SPRING", which are obviously SAUTER. We know, on the other hand, that he was directing the entire operation and must have done some of the analytical work and must have signed some reports, if for no other reason than to justify his position as chief of the group reporting to SESSLER.</p> <p>2. The trace request contained in reference does not specify whether traces are required on Capt. Heinz SCHMALSCHLABER, HEYDEN-RYNSCH, and Frau von HUELSE allegedly nee MUENCHHAUSEN, or only on Frau von HUELSE. We found no trace on a Frau von HUELSE, allegedly nee MUENCHHAUSEN. One of seven children of Generaloberst Kurt Freiherr von HAMMERSTEIN, Maria Luise, was married to a von MUENCHHAUSEN in 1937 and divorced from him in 1952. According to UPWING, (see EGMA 13789 of 4 May 1955) Marie Luise von HAMMERSTEIN, who was married variously to Dr. Jur. Morgens von HARBOW von de HELLEN from 1933 to 1936, to von MUENCHHAUSEN from 1937 to 1952, "held political views contrary to her birth and upbringing" which, in short, meant that she was Communist-oriented. MDEA 7391 of 8 December 1950 also contains information on the pro-Eastern activities of one of the von HAMMERSTEIN daughters. According to reference, Frau von HUELSE was travelling under the name von HUELSE as of 1939. Marie Luise von MUENCHHAUSEN, nee von HAMMERSTEIN, DOB: 27 September 1908, would logically have been travelling under the name von MUENCHHAUSEN as of 1939, having been married to von MUENCHHAUSEN in 1937. She does not appear to be identical with Frau von HUELSE.</p> <p>3. There are extensive traces on Heinz SCHMALSCHLABER, mostly in the AEBATH project and all available in Headquarters. We found no identifiable traces on HEYDEN-RYNSCH.</p>
