1. SUBJ RETURNED PARI 13 JANUARY PRIOR RECEIPT REF. FOLL ANSWERS REF.
2. RE PARA 2, SUBJ INITIALLY FEARED QUERY MADE RE HIS PRODUCTION EFFICIENCY WHICH HE BELIEVED COULD LEAD TO TERMINATION. HE SUBSEQUENTLY CONVINCED MATTER ROUTINE CHECK HIS SECURITY REQUESTED BY HIGHER HEADQUARTERS AND THAT DISCUSSION MUNI AND NOT PARI HAD NO BEARING PERSONAL STATUS. FEEL SITUATION NORMAL AND FURTHER DISCUSSION SHOULD BE AVOIDED.
3. RE PARA 3, HE PAID THROUGH 31 JULY 59.
4. CANNOT ANSWER PARA 3B.
5. RE PARA 3C, SUGGEST PER DIEM ALLOWANCE DM 25 PER DAY. HOWEVER VIEW LONG ILLNESS FEEL 100 U.S. DOLLARS EQUIVALENT SHOULD BE PAID?
6. SUBJ UNABLE COMPLETE MOSKALYK DOCUMENT PROCESSING. SENT LETTER TO MOSKALYK OBTAIN DETAILED BIOG DATA REQUIRED BY GERMANS. FEELS MOSKALYK REPLY WILL ARRIVE CIRCA 30 FEBRUARY WHEN IF NECESSARY SUBJ SHOULD RETURN MUNI CONCLUDE PROCESSING.
