| <p>1. According to information supplied us by [ ] at a recent meeting, AEDOGMA has no intention of remaining in Paris after his present residence permit runs out in early August. Due to the case officer's illness and inability to catch AEDOGMA at home before his return to Paris, we were not able to elicit any information from AEDOGMA about how serious he is about staying in Paris. We, therefore, do not know if AEDOGMA made the above statement to [ ] as an expression of a mood of the moment or if he really meant it. We are certain enough of [ ] reliability to believe firmly that AEDOGMA did make such a statement to</p> <p>2. While we do not know for sure from AEDOGMA that he will leave Paris in the near future, we suspect that his heart is not in his work there. He has made no complaints whatsoever about his work in Paris. In fact he seems happy enough about what he is currently doing, for [ ] and his personal relationship with [ ]. However, the way in which he keeps popping back to Munich; the fact that all his friends are in Munich; his love for Germany in general and Munich in particular; his maintaining of an expensive apartment in Munich, all speak for the possibility that one fine day AEDOGMA will want to return to Munich and take up with Munich Base where he left off. Should this happen and should AEDOGMA insist upon staying here, we would have no other course but to terminate him.</p> <p>3. Since neither AEDOGMA nor [ ] know for certain of the other's relationship to the AIS, it is requested that nothing of the information provided us by [ ] be given directly to AEDOGMA. We had intended to elicit AEDOGMA's views about his present position by asking him why he insisted in keeping up an apartment in Munich which was certainly costing him more money than he could afford.</p> |   |   |
