1. AFTER GIVING LENGTHY CONSIDERATION TO TRACING THE HARTMANN LEAD WITH UPHILL WE FINALLY SURFACED IT TO ALIAS STURM ON 10 OCTOBER 1960. AT A MEETING WITH STURM ON 6 OCTOBER THE UNDERSIGNED DURING A GENERAL DISCUSSION ON RIS MATTERS ASKED HIM IF HE HAD READ THE AEDIPPER-20 BOOK. HE SAID THAT HE HAD NOT, AND THE UNDERSIGNED INDICATED THAT IT WOULD BE A WORTHWHILE EXERCISE SINCE THE BOOK CONTAINED SEVERAL ITEMS OF INTEREST ON RIS ACTIVITIES IN WEST GERMANY.

2. [ ] TOOK A COPY OF THE BOOK TO THE NEXT MEETING ON 10 OCTOBER. IT SHOULD BE NOTED THAT THE MEETING WAS NOT SCHEDULED TO DISCUSS THE BOOK, IT WAS TO CONCERN ITSELF WITH OTHER MATTERS. WHEN THE AGENDA HAD BEEN COVERED STURM WAS HANDED THE BOOK AND HIS ATTENTION DIRECTED TO THE PAGE ON KURT HARTMANN. STURM READ THE ITEM CAREFULLY AND STATED HE FOUND IT OF INTEREST BECAUSE THAT VERY MORNING /10 OCTOBER/ HE HAD BEEN DISCUSSING THE CASE OF A HARTMANN WITH ALIAS RISCHKE. STURM WAS TOLD THAT WHEN THE BOOK DID NOT SAY, AND WHAT WE HAD OBTAINED DURING A RE-INTERVIEW OF AEDIPPER-20 ON THIS ITEM FOLLOWING THE PUBLICATION OF HIS BOOK, WAS THAT ACCORDING TO AEDIPPER-20 HARTMANN WAS DISPATCHED BY THE RIS TO PENETRATE UPHILL, AND THAT THE RIS KNEW PRECISELY HOW THEY WERE GOING TO GO ABOUT IT. UNFORTUNATELY AEDIPPER-20 COULD NO LONGER REMEMBER THE MECHANICS AND CHANNEL TO BE USED BY THE RIS. STURM'S REACTION WAS DIFFICULT TO ANALYSE, BUT IT WAS NOTED THAT HIS ALMOST PERPETUAL SMILE, VANISHED MOMENTARILY, AND HE SAID THAT IN VIEW OF AEDIPPER-20'S STATEMENT ABOUT PENETRATING UPHILL, THAT THE HARTMANN HE HAD DISCUSSED WITH ALIAS RISCHKE COULD NOT BE IDENTICAL WITH THE KURT HARTMANN OF THE BOOK. THERE THE MATTER RESTED AND AT THE CONCLUSION OF THE MEETING [ ] MADE NO EFFORT TO RETRIEVE THE BOOK, WHICH STURM STUCK INTO HIS BRIEFCASE. ON 17 OCTOBER THE UNDERSIGNED RECEIVED A FORMAL MEMORANDUM FROM STURM THANKING US FOR THE TIP, AND ASKING IF KUBARK HAD ANY ADDITIONAL INFORMATION THAT WOULD HELP TO IDENTIFY HARTMANN. HE SAID THAT UPHILL COULD NOT IDENTIFY HIM FROM THE INFORMATION PRESENTED BY AEDIPPER-20. THIS MEMORANDUM HAS NOT YET BEEN ANSWERED.

3. IN VIEW OF THE AZOVE WE CAN BE REASONABLY CERTAIN THAT KURT HARTMANN IS IDENTICAL WITH THE HARTMANN OF THE STURM/RISCHKE DISCUSSION. IN 1955 KURT HARTMANN WAS IN CONTACT WITH COL. HEINZ SCHMALSCHLAGER, AN UPHILL CE OFFICER RUNNING CASES ON THE OUTSIDE FOR RISCHKE. SEE REFERENCE B FOR MORE COMPLETE DETAILS.

4. UNLESS HEADQUARTERS HAS SOME OBJECTION WE PLAN TO BROACH THE MATTER WITH UTILITY BY REFERRING TO THE BOOK WHICH HE HAS READ, AND BY PASSING HIM THE ORIGINAL AEDIPPER-20 REPORT, WHICH WE WILL DESCRIBE AS QUOTE THE PRODUCT OF A RE-INTERVIEW OF THE SOURCE FOLLOWING THE PUBLICATION OF HIS BOOK UNQUOTE. WE CAN FOLLOW-UP THIS BY PASSING THE TRACES LISTED IN PARAGRAPH 5 OF REFERENCE B. PLEASE ADVISE.
