ON 8 JAN CATUSK CALLED OUR ATTENTION TO FACT THAT FILE ON JAROSLAV ZHRUBSKI [] WHICH TURNED OVER TO CATUSK PER REF B CONTAINS CLEAR INDICATION THAT CZECH INTEL SERVICE HAD GREAT INTEREST IN HANSCHWEINZ PORST [] FROM AT LEAST JULY 58 TO MAY 59. CATUSK STATES THAT ACCORDING TO MHRUSH LAW THEY OBLIGED SEE TO IT THAT FEDERAL ATTORNEY, OR CASTIRRUP AS INVESTIGATIVE AGENCY OF PORST CASE, ARE MADE AWARE THIS ASPECT PORST HISTORY. CATUSK WOULD PREFER IF WOFIRM OR AIS TAKE ESSENTIAL ACTION ON OWN INITIATIVE. FYI ALIAS KASTELL SHOWED [] TRANSLATION OF FILE WHICH CLEARLY INDICATES FACTS REPORTED COMMENCING WITH CONTACT REPORT DATED 22 JULY 58. PLEASE ADVISE WHAT ACTION PLANNED.

KASTELL ALSO POINTED OUT CASE OF HEINZ SCHMALSCHLAEGER [] ALSO ALLEGEDLY INVESTIGATED BY ZHRUBSKI. THIS NOT CONFIRMED BY MUNICH FILES.
