4. DOMINIK SKOCZYNSKI: SUBJECT IS BEST ACQUAINTED WITH SKOCZYNSKI, A COMMERCIAL VICE CONSUL WHO HAS BEEN IN THE U.S. FOR FOUR YEARS AND EXPECTS TO REMAIN IN CHICAGO ANOTHER YEAR. PRESENTLY SKOCZYNSKI IS THE BEST INFORMED OFFICER AT THE POLISH COMMERCIAL CONSULATE.
