3. SOURCE HOSTED IRENEUSZ KUBICZEK, COMMERCIAL CONSUL, COMMERCIAL OFFICE AT CHICAGO, TO A 16 FEB VISIT AT THE SADDLE AND CYCLE CLUB, CHICAGO. DURING THE DAY KUBICZEK REPORTED THAT A NEW ORGANIZATION, MEXPO, HAD BEEN ESTABLISHED WITH PEOPLE FROM METAEXPORT AND IS LOCATED IN THE DES PLAINES BUILDING COMPLEX ALONG WITH UNITRONEX, ANOTHER POLISH ORGANIZATION. A NEW MAN IS SCHEDULED TO ARRIVE FROM POLAND TO HEAD MEXPO, NOW TEMPORARILY BEING RUN BY ZIBIGNIEW HALICKI, METAEXPORT DEPUTY DIRECTOR, POLISH COMMERCIAL OFFICE, CHICAGO. WHEN THE NEW HEAD ARRIVES HALICKI WILL BE SECOND IN CHARGE AND THIRD IN LINE WILL BE MARIAN LUGOWSKI, METAEXPORT REPRESENTATIVE IN USA.

KUBICZEK REPORTS COMMERCIAL MATTERS TO STRZUJ (FNU), HEAD OF POLISH COMMERCIAL OPERATIONS IN THE US (ALTHOUGH SOURCE SPELLED OUT NAME, IT PROBABLY IS IDENTICAL TO STANISLAW, COMMERCIAL COUNSELOR, POLISH COMMERCIAL COUNSELORS OFFICE, NEW YORK). KUBICZEK AND STRZUJ SERVED IN LONDON TOGETHER SEVERAL YEARS AGO. KUBICZEK WAS BORN IN THE SAME UPPER SILESIA VIL- LAGE AS (POLISH PRIME MINISTER) GIEREK, AND THEIR FAMILIES

KNEW EACH OTHER WELL. KUBICZEK COMMENTED TO THE SOURCE THAT IT WAS THROUGH THIS CONNECTION THAT HE GOT HIS PRESENT CHICAGO ASSIGNMENT.

5. KUBICZEK'S WIFE, ZOFIA, IS A DOCTOR BUT SINCE SHE DOES NOT HAVE A LICENSE TO WORK IN THE U.S. SHE CANNOT WORK, AND SHE HAS BECOME SOMEWHAT FRUSTRATED BY THIS. KUBICZEK IS OUTGOING, A TOTAL WESTERNER, AND A NAVAL ENGINEER. HE SERVED IN LONDON FOR FOUR YEARS REPORTEDLY IN THE SALE OF SHIPS. HE RETURNED TO POLAND TO HANDLE ALL POLISH SHIP SALES TO THE WESTERN WORLD. KUBICZEK IS HAPPY WITH HIS CHICAGO ASSIGNMENT AND DOES NOT CONSIDER IT A STEP DOWN, HE SAW IT AS HIS LAST OPPORTUNITY TO GET HIS FAMILY TO THE WEST WHERE HIS TWO BOYS, JAROSCH, 13 AND MACIEJ, 16, COULD PERFECT THEIR ENGLISH. MACIEJ ATTENDS CHICAGO'S SENN HIGH SCHOOL.

6. SOURCE HAS MET ZENON KROL, OSKOL, POLISH COMMERCIAL OFFICE, BUT DOES NOT KNOW HIM WELL. KROL IS SURPRISINGLY ALOOF BUT THOROUGHLY WESTERNIZED. SOURCE DESCRIBED KROL AS GETTING FAT AND HAPPY IN CHICAGO. ALTHOUGH KROL HAS THE UPPER HAND AT UNITRONEX HE DOES NOT HAVE MUCH AUTHORITY AROUND OFFICIAL POLES. KROL IS EASY GOING AND GREGARIOUS. HE
