1. @GRAMM was scheduled to have had a meeting with subject on 6 Aug. @KUTZBACH had not as yet received the report of this meeting. At the previous meeting the STB case officer had reduced @GRAMM's salary. @KUTZBACH and @NABINGER have been to Hamburg to see the UPHILL case officer handling @GRAMM. The case officer does not trust @GRAMM. @KUTZBACH and @NABINGER feel that the UPHILL case officer is very capable and well qualified for running the operation. I asked @KUTZBACH whether or not any tests of the agent had been made and their reply was no. The plans for the future consist of an attempt to get ANTOS to meet with the UPHILL agent some place in the West.

2. @KUTZBACH said that on 11 Aug. he was planning on driving to Bonn to discuss the case with the ASBW. The UPHILL agent has his Abitur and has been studying Russian and English for the last 1½ years. UPHILL feels that he is more pro-Czech than pro-German and that he may be cooperating with the East. They recently surveilled a meeting that had been scheduled between AJAX and the Czech IS case officer. AJAX was to walk up and down a street and the CIS was to have made contact with him there. AJAX spoke with two individuals on the street during the period in which the meeting was to have taken place. However, when the UPHILL case officer later debriefed AJAX, AJAX denied having met anyone. AJAX claims that the next meeting with the CIS is to take place in March 1961. Earlier this year (apparently in the Spring) AJAX went to Vienna with UPHILL's approval. @KUTZBACH now feels that the CIS might have made contact with him there. AJAX's EBI's still consist of getting a position with the German Army. Under normal circumstances AJAX would serve for two years and would probably immediately go to officers school, particularly in view of his education and knowledge of Russian and English. @KUTZBACH's trip to Bonn is to make certain that AJAX remains a low ranking non-commissioned officer at the best.

3. @KUTZBACH was not familiar with the latest details on the case but as usual tried to bluff his way through. He stated that there had been little activity since the beginning of this year.
