1. Most of the meeting with @KUTZBACH was spent discussing subject case. At the meeting scheduled circa 27 August Subject went to East Berlin as usual and surprisingly enough met with ANTOS. EKI's at that meeting included the gathering of information on various individuals in West Germany and one well known scientist was mentioned. UPHILL is completely convinced that Subject is dishonest at least in part of his dealings with them. UPHILL had Subject surveilled and Subject made a mysterious trip to a cemetery where he rummaged around near one of the gravestones. UPHILL feels it is possible that Subject was servicing a dead letter drop. When questioned about this Subject denied he had ever been to the cemetery concerned. Getting back to Subject's trip to Berlin circa 27 August, ANTOS did drive Subject over into West Berlin but not deep into the Western Sector. There is still no way for Subject to get in touch with the Czech IS and UPHILL views this as extremely strange. @KUTZBACH went into a long theoretical discussion as to why if the CIS were in fact playing the case against UPHILL they would certainly have given the man an accommodation address inside the GDR. Somewhat more startlingly and a very good reflection of @KUTZBACH's capabilities was the development that he was not aware of the travel restrictions on West Germans traveling from West Berlin to East Berlin. He passed this off quickly saying that since Subject had the telephone number for the Czech Embassy Subject would probably phone if he were not able to get into East Berlin on 8 October when his next meeting was scheduled. @KUTZBACH has not as yet had heard whether the 8 October meeting has taken place. @KUTZBACH hopes that Subject will be able to force the CIS to schedule the next meeting in Denmark.

2. @KUTZBACH noted that their agent has had trouble receiving the ONVL from the GDR. After receiving a written piece of correspondence succeeded in hearing instructions. The CIS scheduled a meeting for the near future in Austria, believed to be in the area of Mondsee, and permitted the agent to choose the time. The undersigned is in agreement with @KUTZBACH that this is quite a change in MO for the CIS.

3. Contact by dead letter drop with continues. Subject has been asked to gather information on 2 individuals who are friends of an UPHILL field agent (apparently female). @KUTZBACH believes that the CIS is extremely clever in this instance and is purposely concealing the identity of the real target of investigation from .
