1. In accordance with the terms of Project TFOASIS, CAMLET-1 was engaged under oral contract for an indefinite period of time. The effective date of the oral contract is 19 February 1954.

2. Until further notice by the KUBARK Case Officer, CAMLET-1 will be paid .06 DMW per copy of the large format PBBLOOM and .06 DMW per copy of the small format PBBLOOM. Until otherwise specified by KUBARK, CAMLET-1 will publish 30,000 copies of the large format PBBLOOM and 45,000 copies of the small format PBBLOOM per week. These items will be paid in DMW once monthly.

3. Once a month, until otherwise specified by KUBARK, we will pay CAMLET-1 at the rate of 4,000.00 DMW per week for distribution costs incurred distributing the monthly production of the large and small format PBBLOOM in the GDR. These payments shall be based on bona fide and accurate bills and receipts for distribution costs submitted to us by CAMLET-1 once monthly.

4. Payments and accountings for all other propaganda items requested by the TFOASIS Case Officer produced and distributed for us by CAMLET-1 shall be treated as separate, special one-time operations, not within the purview of this statement of oral agreement.

5. In accordance with oral agreement, CAMLET-1 is not entitled to annual or sick leave benefits, disability compensation or other rights, nor will his dependents be entitled to death benefits.

6. Subject was not promised assistance in the event capture, exile or flight.

7. Termination of oral agreement is at either party's discretion.

8. CAMLET-1 treats all connections and dealings with the KUBARK Case Officer as highly confidential. CAMLET-1 observes security measures ordinarily associated with the functioning of a PP-type project.

9. No commitments, other than those stated above, have been made to CAMLET-1.
