LATE 31 AUG DISCUSSED TELEGRAF COUNTERPART LOAN APPLICATION IN DETAIL WITH  
 GUFLER, BRANDIN AND HILLENBRAND (ALSO RECEIVED HILLENBRAND), CHIEF POLITICAL  
 AFFAIRS USBER. BRANDIN ADVISED COMMITTEE IN ADDITION TELEGRAF LOAN FOUR MILLION  
 DMW PERMIT HIM CONSTRUCT MAJOR PRINTING PLANT WEST BERLN. BOTH LOAN APPLICATIONS  
 CONSIDERED TOGETHER BY COMMITTEE AND BERLN SENAT REPS. USBER REPS GIVEN GENERAL  
 EYES ONLY BRIEFING BACKGROUND OF CAMLET CASE AND REFLECTIONS CAMLET FRAUD BOTH  
 KUBARK AND STATE. ALTHO BRIEFING THIS CASE WAS, AS YOU WILL RECALL, PREVIOUSLY  
 GIVEN TO HENRY PARKMAN, GUFLER'S PREDECESSOR AND TO DOWLING IN BONN, USBER  
 REPS WERE NOT AWARE OF BACKGROUND. EVEN PRIOR BEING ADVISED BACKGROUND CAMLET  
 FRAUD, USBER REPS, PARTICULARLY POLITICAL AFFAIRS, RELUCTANT APPROVE LOANS IN  
 CASE OF TELEGRAF, DUE LEFT OF SPD EDITORIAL LINE AND SOMEWHAT ANTI-AMERICAN  
 TONE AT TIMES AND IN CASE OF SPRINGER IN VIEW EDITORIAL LINE OF DIE WELT PLUS  
 FACT SPRINGER WHO ALLEGEDLY EARNED (PORTION GARBLED-BEING SERVICED) PROFIT OVER  
 20 MILLION DMW LAST YEAR NOT PARTICULARLY DESERVING CANDIDATE. ON BASIS THESE  
 FACTORS PLUS CAMLET FRAUD, GUFLER OF FIRM OPINION AND OTHER USBER REPS CONCURRED

LOANS UNDER NO CIRCUMSTANCES SHOULD BE GRANTED AND WILL BE VETOED BY BRANDIN AS US REP COMMITTEE. GUFLE INSTRUCTED BRANDIN THINK UP INNOCUOUS OSTENSIBLE REASON FOR REFUSAL. NOTE THIS CONNECTION LOAN SHOULD NOT BE VETOED PUBLICLY AT LEAST ON BASIS POLITICAL GROUNDS, I.E., EDITORIAL LINE OF EITHER TELEGRAF OR DIE WELT. USBER ASKED WHETHER KUBARK WILLING PERMIT USBER USE ANY PART OF INFO ON CAMLET FRAUD COUNTER POSSIBLE POLITICAL PRESSURE WHICH MAY BE BROUGHT TO BEAR CONNECTION TELEGRAF LOAN SUBSEQUENT TO AMERICAN VETO. USBER WAS ADVISED NO OBJECTION TO THEIR MAKING FLAT STATEMENT; IF ABSOLUTELY NECESSARY, THAT PAST U.S. DEALINGS WITH CAMLET HAVE PROVED UNSATISFACTORY (NOTE THIS CAN BE SUBSTANTIATED ON BASIS STATE AS WELL AS KUBARK DEALINGS WITH CAMLET) BUT THAT NO DETAIL BACKGROUND CAMLET CASE OR CAMLET FRAUD COULD BE AUTHORIZED BY [ ] FOR PASSING BY USBER TO GERMANS WITHOUT FRAN AND/OR WASH APPROVAL. WHILE FURTHER DETAILED REASONS FOR TURNING DOWN LOAN MAY WELL NOT BE NECESSARY SINCE DOUBT IF EITHER [ ] SPD, BOTH OF WHOM WELL AWARE CAMLET FRAUD, LIKELY ATTEMPT OVERT PRESSURE, WOULD APPRECIATE ADDRESSEES COMMENTS ON THIS POINT.
