1. CONCUR BERLIN'S ACTION ON CAMLET LOAN APPLICATION.

2. BELIEVE REFUSAL OF LOAN SHOULD BE HANDLED DISCREETLY. SHOULD BE NO PUBLICITY ANY PART OF OUR FORMER RELATIONSHIP WITH CAMLET. HARD TO SEE WHAT POLITICAL PRESSURE COULD BE BROUGHT ON USBER TO WARRANT REVEALING ODYOKE HAS BEEN SWINDLED IN ONE OF HIS MAJOR ANTI-COMMIE EFFORTS BASED IN BERLIN. IF ANY ASPECT ~~CAMLET~~ ^{CAMLET} CASE AIRED ~~WILL~~ WILL FOLLOW WITH HIS VERSION WHICH IN TURN WILL FORCE US TO PUBLISH MORE DETAILS AND SO FORTH. THIS WOULD SUPPLY WELCOME AMMUNITION TO COMMIES AND CREATE FURTHER FRICTION AND DISSENSIONS IN WESTERN CAMP.

3. HAVING MADE KNOWN FACTS IN OUR POSSESSION RE CAMLET TO PROPER ODYOKE AUTHORITIES, KUBARK RESPONSIBILITY FOR ADVISING ODACID RE PENDING LOAN HAS BEEN DISCHARGED.
