2. INTEND ADVISE [] TELL CAMLET I SEE BRANDIN, USBER ECONAF, WHO WILL GIVE INNOCUOUS REASON FOR TURNDOWN PER REF A. BRANDIN COULD ALSO STATE THAT PAST U.S. DEALINGS WITH CAMLET I PROVED UNSATISFACTORY IF THIS DEEMED DESIRABLE. ASSUME BOB/USBER AGREEMENT THIS COURSE OF ACTION BACKSTOPPED WITH ODACID WASH AND BONN PER REFS B AND C. FEEL THIS ESSENTIAL BEFORE USBER GOES OUT ON LIMB.
