1. ON CHANCE CAMLET MIGHT CONTACT [] WHILE WASH, HEREWITH TWO ASPECTS
2 JAN [] /CAMLET MTG WHICH WE HAVE NOT YET HAD CHANCE REPORT. MTG WAS
SOUGHT BY CAMLET AND TOOK PLACE BONN.

2. CAMLET INQUIRED RE STATUS HIS LOAN APPLICATION, EXPRESSED HOPE THAT
HIS EARLIER "TROUBLES" WITH KUBARK NOT INFLUENCING DECISION. ADVISED HIM
THAT KUBARK NOT AT ALL INVOLVED IN DECISION AND NOT EVEN CONSULTED. ALSO
TOLD HIM THAT HIS APPLICATION HAD BEEN OR WOULD BE REJECTED BUT THAT
AMERICAN ATTITUDES VIS-A-VIS CAMLET PLAYED NO ROLE ON BASIS ADVICE FROM
EMBASSY PRIOR MTG, TOLD CAMLET IN CONFIDENCE THAT AMBASSADOR HAD DECIDED THAT
PUBLISHING FIRMS WHICH HAD RECEIVED PREVIOUS CREDITS AND WHICH WERE GOING
CONCERNS WOULD BE GRANTED NO FURTHER CREDITS AND THAT THIS PRINCIPLE HAD BEEN
DECISIVE IN REJECTION BOTH HIS AND SPRINGER'S APPLICATION. CAMLET STATED THIS
MADE SENSE AND THAT HE WAS SATISFIED. PLS NOTE THAT THIS EXPLANATION DIFFERS
SLIGHTLY FROM THAT GIVEN [] BY [] DURING FORMER'S VISIT WASH. REQUEST
ABOVE LINE BE GIVEN CAMLET SHOULD HE ATTEMPT DOUBLECHECK. FYI SAME LINE
SUBSEQUENTLY ALSO GIVEN [] WHO ADVISED THAT QKELUSION HAD SOLVED CAMLET'S

DIFFICULTY BY GUARANTEEING HIS LOAN.

3. NOTING THAT [] HAD SPECIAL HUNGARIAN LCPAGAN EDITION PRINTED BY [], CAMLET EXPRESSED APPREHENSION THAT THIS WAS PRELUDE TO [] SOON OR EVENTUALLY MOVING ALL LCPAGAN BUSINESS TO []. CAMLET STATED THAT THIS WOULD HIT HIM HARD FINANCIALLY, ESPECIALLY IN VIEW HIS HAVING BOUGHT AT []'S INSISTENCE EXPENSIVE SPECIAL MACHINERY FOR PRINTING LCPAGAN. TOLD CAMLET THAT WE WERE NOT UP TO DATE ON LCPAGAN AND THAT ANYTHING WE SAID WOULD BE SPECULATION.
