protective custody pending outcome of negotiations with London to extradite him to Germany.

1 Feb: transferred to Lager Scheveningen at The Hague.

10 Feb: granted official permission to return to Germany.

17 Mar: returned to Germany via Venlo.

Claims numerous interrogations established beyond shadow of doubt that he was able through clean criminal police work to capture, fully debrief and turn dropped parachute agents, learning their codes, etc. Declares the Dutch papers described him as a "correct police official" who had not engaged in crimes against humanity.

10 Sep: Denazification court classified him as not chargeable under the law.

Remained home for unknown period to write book "Das Englandspiel".

JOINED ZIPPER.

1951: reported to be giving UJ-DROLLERY # 502 case "expert handling"; UJ-DROLLERIES # 9, 100, 705, 1000, 1001.

1953: UJ-DROSEKY candidate.

UJ-DROLLERY # 1000: sub-source V-5009 (formerly V-7627.3) is a business man in the Netherlands; the fact that the ultimate source is in an allied area has caused the case to be given "special handling" by ZIPPER and no operational reports have been received by POB.

5 August: KLAUSNER informed [] that SCHREIEDER had been hired originally in 1949 for GV H with expectation that his well-known activity with Gestapo on "Rote Kapelle" would qualify him for work as a CE officer; through personal contacts he established for GV H cases # 705 and 1000; latter has since proved to be rather a swindle; KLAUSNER is not pleased with # 9; accordingly, it is planned to transfer SCHREIEDER soon to the BfV.
