SPECIFIC - Trip of Junior Ratapaharn Officers to Europe

Reference: FTBA-4785

1. Attached herewith is a list received from C Jair manifests which lists the names of the Junior Ratapaharn members who made the trip to Europe pointed out in reference.

2. C J submitted a list to C J on 8 October of the members intending to make the trip. A check of the two lists indicates that several of the members stayed in Bangkok, at least for the present. C J list is attached herewith also. The names not checked didn't make the trip according to the manifest.

3. C J reported that Dr. E. SCHROCK, a German National who is presently supported by General PRAYOON Phamornmontri, was accompanying the group on the trip. SCHROCK obtained a job with the Union Hotel (Saha Rongram Co.) and the Thai Commercial Trust Corp. (Sethasampan Thai) through the support of PRAYOON. The Thai Commercial Trust Corporation is acting as commission agents in ordering goods for the Thai Government. Dr. SCHROCK is acting as advisor and doing all their correspondence. SCHROCK receives salaries from both places.

4. It was added by C J that on 11 October 1954, General PHAO Sriyanond "granted" the Thai Financial Syndicate the permission to allocate 1,500,000 tics for the complete expenses for the trip to Europe.

5. It should be most convenient for PHAO to have the Junior Ratapaharn Members on a trip while he (PHAO) is also away from Bangkok. These Junior Members being the supporters of SARIT should weaken SARIT even further for the duration of PHAO's absence. We wonder if PHAO has not engineered this whole deal to leave SARIT's group so emasculated that it would not be able to cause trouble while PHAO was absent.
