1. Reference is made to our letter of 16 November 1961, subject and file as above.

2. OSI PACAF has furnished the following additional information:

a. Major COOPER and TSgt CRAWFORD visited Bangkok, Thailand during August 1961 as members of an inspection team which was quartered at the Grand Hotel. On 18 August 1961, the team was given a cocktail party and boat ride, which were arranged by the management of the Grand Hotel. Dr. SCHRATT, COOPER and CRAWFORD were present at both functions. COOPER and CRAWFORD were informed by Lt Colonel ROBERT C. DUBOSE, another member of the inspection team, that SCHRATT is a former high Nazi official who came to Bangkok eleven years ago and was currently employed by the owner of the Grand Hotel, believed to be Dr. SUCHIT HIRANPRUECK, a wealthy Thai. (S) (SCP-3)

b. COOPER and CRAWFORD furnished the following physical description of Dr. SCHRATT: Five feet ten to six feet tall; 180-190 pounds; stocky build, heavy frame; extremely erect carriage; greying hair with receding hairline, combed straight back; square, full face; prominent cheeks; dark glasses with dark rims and heavy eyebrows. (S) (SCP-3)

c. Lt Colonel DUBOSE is presently on TDY. On his return on or about 22, 23 November 1961, he will be interviewed. Other individuals who may have pertinent information are Major BARTON W. TALBOT, former Liaison Officer, Bangkok, now assigned to the 1st Aero Medical Transportation Group, Brooks AFB, Texas; and Captain LEO J. EHMANN, now on duty at Bangkok as Assistant Liaison Officer, 1503d Air Transport Wing. (S) (SCP-3)
