MEMORANDUM FOR: Chief of Operations, Deputy Director (Plans)

SUBJECT: Recommendation for Welcoming Senior West German Internal Security Officials

REFERENCE: CSI 60-3, 21 February 1957

1. This memorandum contains recommendations submitted for DEF/COF approval. The recommendations are contained in paragraphs 2 and 4.

2. It is recommended that you welcome German Federal Republic officials President Hubert SCHNEIDER of the Bundesamt fuer Verfassungsschutz (BfV - Office for Protection of Constitution) and Ministerialrat Dr. Rudolf TOEKA, responsible official for BfV affairs in the Interior Ministry, in the best interests of our activities in West Germany. They will be in the U.S. at our invitation from 7 May to approximately 21 May 1957. If you concur with this recommendation, the time of 0930, 13 May 1957 is suggested.

3. The primary objective for these visits is to improve our liaison with the BfV. There has been only one previous visitor to Washington from the BfV, the unfortunate Otto Jahn. Both of the BfV visitors, along with a considerable number of other BfV personnel, have been in London. The current trip has been slow in materializing, partly because the personnel situation in the BfV was far from clear. It now appears, though, that President SCHNEIDER is going to be around for some time to come.

4. It is suggested that the appropriate time element for your welcoming remarks is 25-30 minutes and that they could well be limited to generalities which reflect your extensive background in West Germany and Berlin. It would be appreciated if your remarks indicated our confidence in their professional efforts and emphasized that while the Jahn case resulted in a lot of unpleasant publicity it did not shake our faith in the general reliability of the German Civil Service and the BfV in particular.

BIOGRAPHIC INFORMATION

Hubert SCHRUEBBERS

President of the German Federal Republic's Office for the Protection of the Constitution (BfV - internal security organization)

1. SCHRUEBBERS was born 3 November 1907 in Recklingshausen, North Rhine-Westphalia, Germany. He is a graduate lawyer, passing his first legal examinations in July 1931. SCHRUEBBERS first served as an assessor in Berlin beginning in 1935 and subsequently held the post of prosecuting attorney in federal and state courts from 1939 to August 1955 in the cities of Bochum, Dortmund, Hamm, Arnberg, Cologne, Karlsruhe, and Düsseldorf.

2. He served with the German Army from August 1943 until May 1946, attaining the rank of sergeant. He was captured and interned by the British in September 1944 and released sometime during May 1946. He was never a member of the NSDAP or active in any political group.

3. On 1 August 1955 SCHRUEBBERS assumed the provisional presidency of the BfV and received the official appointment 19 December 1955. He has never been to the United States, but does understand a fair amount of English.

4. SCHRUEBBERS is married and the father of two teen-aged children. He is described as approximately 5' 8" tall, dark hair, medium build, and appearing to be in his early fifties.
