SUBJECT: LIASON/CAVATA PROPOSED HQS VISIT OF CHIEF, CAVATA

ACTION REQUIRED REFERENCES

1. AS PREVIOUSLY DISCUSSED WITH CHIEF, EE AND WITH [] DURING HIS TDY VISIT TO THE GERMAN STATION, THE BONN BASE REQUEST HEADQUARTERS AUTHORITY IN ACCORDANCE WITH REF TO EXTEND AN INVITATION TO CHIEF, CAVATA TO VISIT HQS FOR BRIEFINGS AND DISCUSSIONS TENTATIVELY SCHEDULED FOR APRIL OR MAY 1965. WE SUGGEST ONE WEEK TO TEN DAYS IN WASHINGTON AND AN ADDITIONAL WEEK OF TRAVEL IN THE U. S.

2. THE LAST VISIT OF SUBJ WAS IN 1957 SHORTLY AFTER HE ASSUMED HIS PRESENT POSITION. SEVERAL TIMES DURING RECENT MONTHS HE HAS MENTIONED THIS 1957 VISIT AND REMARKED THAT DUE TO HIS NEWNESS IN THE JOB, MANY OF THE DISCUSSIONS IN WASHINGTON AT THE TIME WENT OVER HIS HEAD. IN THE MEANTIME, SUBJ HAS GAINED A GREAT DEAL OF EXPERIENCE, MUCH OF WHICH HAS BEEN LEARNED THE HARD WAY.

3. AS A RESULT OF THE TELEPHONE AFFAIR AND THE SUBSEQUENT PURGING AND RETIREMENT OF SEVERAL SENIOR CAVATA OFFICIALS, THE ORGANIZATION IS BEGINNING A NEW PHASE IN ITS EXPERIENCE WITH NEW LEADERS IN KEY POSITIONS AND WITH A RENEWED ENDORSEMENT OF ITS WORK FROM THE BUNDESTAG.

4. WITH THE GRADUAL REALIGNMENT OF KUBARK'S OPERATIONS AS A RESULT OF THE REORGANIZATION OF THE BONN-COLOGNE AREA, AS WELL AS THE INEVITABLE FUTURE TRANSFER OF CALLIKAK TO THE GERMANS, WE FEEL THAT A CAREFULLY PLANNED PROGRAM OF INVITATIONS AND TRAINING OF SELECT CAVATA OFFICIALS WOULD BE DISTRICTLY IN KUBARK'S INTEREST WITH RESPECT TO ITS LONG RANGE OBJECTIVES IN GERMANY. SINCE HE HAS PERSONALLY EXPRESSED A DESIRE TO REVISIT THE U. S. AND, SINCE SUCH A PROGRAM SHOULD HAVE THE FULL SUPPORT OF ITS CHIEF, WE ARE PROPOSING SUBJ AS THE FIRST CANDIDATE FOR A VISIT.

5. UPON RECEIPT OF HQS APPROVAL AND PROPOSED DATES FOR SUCH A VISIT, WE WILL FORWARD DETAILED SUGGESTIONS FOR BRIEFING TOPICS. WE FEEL IT IS IMPORTANT TO GIVE SUBJ A THOROUGH EXPOSURE TO PERSONNEL, SECURITY AND TRAINING TECHNIQUES - LCFLUTTER, JOINT OPERATIONS, AND GENERAL BRIEFINGS ON KUBARK AND ITS ROLE IN ODYOKE. AN EFFORT SHOULD ALSO BE MADE TO HAVE HIM MEET AND BE BRIEFED BY CHIEF, ODENVY, AS WELL AS VISIT ACSI AND OSI AT THE PENTAGON. THE SUBJ ALSO HAS A STANDING INVITATION TO VISIT SENATOR DODD OF CONNECTICUT, WHICH HE WOULD NO DOUBT PREFER HAVING ARRANGED THRU KUBARK. WITH RESPECT TO EXCURSIONS, WE SUGGEST A TRIP TO REDSTONE ARSENAL AND CAPE KENNEDY, AS WELL AS SOME TIME IN NEW YORK.

6. RE FINANCES, WE PLAN TO SUGGEST TO SUBJ THAT HIS GOVT PAY HIS PLANE FARE TO NEW YORK AND KUBARK WOULD PICK UP THE BILL DURING HIS STAY IN THE U.S.

7. TO ASSIST HQS DURING THE VISIT WE PROPOSE THAT []
[] ESCORT THE SUBJ.

8. THE CHIEF OF STATION CONCURS IN THIS PROPOSAL.
