LIQUIDATION REPORTS.

I. GENERAL.

- a) The War Room will issue short papers, based chiefly on interrogation reports, outlining the information available to the War Room on the RSHA formations set out in Appendix I, providing always that sufficient material for such papers has been received from the Field to justify the paper. These papers are not intended to be an exhaustive study on each subject.

II. NATURE OF PAPERS.

- b) As soon as it is felt that the main points concerning the history, personnel, enterprises and main agents of each formation have been covered by interrogation the War Room liquidation report will be issued on each formation.
- c) The issue of these War Room liquidation reports will not mean that there is no further action to be taken in the Field against the formation concerned. The issue of the report will indicate that the bulk of interrogation about the formation has been completed, although there may still be details to clear up and personnel and agents to be arrested.

III. THE USE OF THESE LIQUIDATION REPORTS AS ARREST LISTS.

- d) Each liquidation report will contain a list of all the personnel of the formation at approximately 1 January 1945, or the nearest date thereto as known to the War Room. The fact that any officer or Sonderfuehrer has been arrested will be noted against his name if his arrest is recorded in the War Room at the time of publication. If such an arrest is not recorded, no entry will be made against the name. The arrest of NCOs and other ranks will not ordinarily be recorded unless the NCO or other rank held an extremely important position in the formation concerned.

IV. TIME AND METHOD OF ISSUE.

- e) Addressees will find that an asterisk has been placed against certain of the formations enumerated in the Appendix. These asterisks will mean that there is sufficient information already available on the subject in the War Room and that liquidation reports are in preparation.
- f) In the case of some formations, the War Room feels that the completion of one or more current Field interrogations would materially assist the completion of liquidation reports on the formations concerned. In such cases the name or names of the prisoners whose reports are outstanding, followed by the zone and date of arrest follow the name of the formations in Appendix I attached.

V. SPECIAL NOTE RE S.D. ABSCHNITTE AND GESTAPOSTELLEN.

- g) It is considered that it would be unprofitable to write papers on these Abschnitte or Stellen and their subordinate formations as, in fact, these formations are merely of local interest in Germany. It is proposed therefore to write general papers showing the usual set-up in each type of formation as a general guide.
