PRESENT PLAN, SUBJECT POSSIBLE HQS VARIATIONS IMPLIED REF A, FOR [ ] FURNISH GRCAMERA ONLY BASIC FACT ANOSOV CAUGHT IN FLAGRANTE, LETTING GRCAMERA TAKE LEAD FROM THERE. THERE NO ASSURANCE HOWEVER OF GRCAMERA FOLLOW UP.

2. FYI, [ ] REPORTED HE TOLD BY GRENGULF/5 30 SEP THAT IN COURSE OF SOV AMB VISIT TO CHANCELLOR KLAUS DAY AFTER ANOSOV PICK UP, AMB REQUESTED NO PNG OR OTHER ACTION AGAINST ANOSOV AND NO PUBLICITY OF AFFAIR.
