<p>With apologies for the totally unexplainable delay in responding to references, there is summarized below the current state of [ ] relations with DITO contacts. Rather than writing a separate piece on each, I am including all of them here inasmuch as the nature and substance of our DITO contacts hardly merits separate dispatches.</p> <p>a. GRCANERA - He remains our principal GRANGE contact, although he is certainly not a controlled agent. His major WGLINE activity on our behalf in the recent past has been the surfacing of certain FJSTHAL activities in Austria. (See [ ] 3916.) More recently, he has been trying to arrange for the travel of one of his associates on behalf of the BUKKERT program. Generally, he follows a completely pro-LIBERAL editorial policy and both he and his principal writers spontaneously support LIBERAL positions. His ability to accept guidance is circumscribed by the nature of his publication and by the responsible position which it enjoys locally. It is usually not possible to place spot WGLINE items with him. He is met by me approximately once every four to six weeks for lunch. Expenses are limited to the purchase of an occasional luncheon and a Christmas gift. The total amount of money required annually is a maximum of \$150. [ ] has met GRCANERA once, and could handle him in my absence.</p>

b. [ ] - Last fall's demise of his newspaper, Identity A, and his more recent sale of his last 20% interest in Identity B, leaves him without WOLINE significance. During an occasional luncheon (always at his expense), he continues to be a source of local gossip, high level and otherwise, but his operational usefulness has come to an end. He has apparently also fallen on rather serious, hard times. I expect that he will shortly withdraw completely from the business scene and retire. He is, of course, 71 years of age.

c. [ ] - I mention [ ] here, in spite of Reference A, simply to report that he has been used exclusively as a WOLINE source during the last year or so. Whether or not he has any WOLINE potential is somewhat uncertain. We will not be able to determine this until we have removed [ ] from this operation, a much needed change, we hope to make in the very near future. His current position is that of Identity C.

d. Identity of [ ] 4681, who is the editor of Identity B, is under development by [ ] This shows considerable promise simply because his publication is capable of absorbing spot news, unlike GRCANERA's publication. [ ] will shortly submit to you a more comprehensive report on the status of his efforts. A total of \$150 per annum should suffice to cover the relationship.

e. [ ] - The development of this FJPLEAD specialist has been extensively reported to you in separate correspondence.
