IF OPPORTUNITY ARISES DISCUSSION MIGHT ALSO INCLUDE PROBE FOR INFO HEINEMANN'S THINKING SUCH POLITICAL ISSUES AS RELATIONS WITH DDR, HIS ESTIMATE RE CENTRAL EUROPEAN DISENGAGEMENT PROPOSALS AND "SMALL STEPS" THEORY, EASTERN INTENTIONS BRLN. DOES HEINEMANN'S CHURCH ACTIVITY BRING HIM IN CONTACT EASTERN CHURCH OFFICIALS. IF SO, WHO, AND PURPOSE CONTACT. REPLIES SHOULD PROVIDE INDICATION POTENTIAL USEFULNESS CAHELM-HEINEMANN FRIENDSHIP AND VALUE HEINEMANN AS CONTACT.

3. FYI: HEINEMANN SERVED BRIEF PERIOD AS CDU INTERIOR MINISTER ADENAUER GOVERNMENT 49-50 BUT RESIGNED IN PROTEST ADENAUER FAILURE INFORM HIM OF MEMO ON WEST GERMAN SECURITY SUBMITTED BY ADENAUER TO HIGH COMMISSIONERS. NO RECORD DEFENSE POST MENTIONED REF. ENTERED BUNDESTAG 57 AS SPD DEPUTY AND NOW MEMBER SPD FRAKTIONSVORSTAND AS WELL AS BUNDESTAG FOREIGN AFFAIRS AND ALL-GERMAN AND BRLN AFFAIRS COMMITTEES.
