MEMORANDUM OF ORAL AGREEMENT

Date: 29 September 1965

TO : Chief, EE
VIA : Contract Approving Officer
FROM : Chief of Base, Hamburg
SUBJECT: Engagement of CAHELM as Independent Contractor

1. Term and Project Charge. Subject individual has been engaged under oral contract and is to be charged against Station Overhead. The effective date of the oral contract is 6 November 1964, and shall continue thereafter for an indefinite period, subject to termination by ODYOKE upon 30 days actual notice.
2. Security Approval. The appropriate security approval for Subject's use has been obtained. Type POA Date 25 Feb 1965.
3. Citizenship. Subject is a foreign national.
4. Compensation. Subject will be paid DM 250.00 per month. The approximate equivalent of this amount in PEPRIME currency is 62.50 dollars. Subject receives only operational expenses in addition to his salary. (See Paragraph 7)

6. Quarters and/or Subsistence.

7. Operational Expenses. Subject will be reimbursed for operational expenses for travelling to meet and entertain target personalities at KUBARK request.
