MEMORANDUM OF ORAL AGREEMENTS

SUBJECT: Engagement of CAHELM/1, as (Independent Contractor)


1. Term and Project Charge. The subject individual has been engaged under oral contract and is to be charged against TPTERRY OOA. The effective date of the oral contract is 1 November 1966 and shall continue thereafter for an indefinite period subject to termination by LNFORT upon 30 days' actual notice except as noted in paragraph 8.

2. Security Approval. The appropriate security approval for subject's use has been obtained. Type OA Date 27 June 1966.

3. Citizenship. The subject is a foreign national.

4. Compensation. The subject will be paid DM 800 per month. The approximate equivalent of this amount in WOLADY currency is 200 dollars.

(a) The Subject will not be furnished quarters or subsistence.

(b) No commitments have been made regarding additional compensation to accommodate increased cost-of-living and quarters expense.

7. Operational Expenses.

(a) The subject will be reimbursed for operational expenses, incurred with the prior approval of his case officer.

8. Other Commitments. The following additional commitments have been made to the subject: If terminated by LNFORT before 30 April 1966, his salary will be paid thru that date, unless he has in the meantime found other employment paying him an equivalent salary.
