Sergei Lvovich SHEBALIN

1. It is requested that your office make the necessary arrangements to legalize the entry into the United States this year of Sergei Lvovich SHEBALIN, formerly Rostislav Lvovich ANTONOV; his wife, Tatiana Afanasiyevna (RAUN) SHEBALINA; and his six year old daughter, Margarita, under the authority of Section 203 a 1 of the Immigration and Nationality Act. Operational considerations render it essential for Subject to be brought out of Austria and into the United States with a minimum of delay.

c. Admission to the United States is contingent upon favorable results of a psychiatric examination to be conducted upon arrival in the United States.

2. This request is based upon Subject's past and potential usefulness to this Agency:

a. Service to date

Subject, a former captain of the Soviet Army and later General VLASSOV'S adjutant, has been utilized under various projects of the SR Division, since November 1951. In two of the projects Subject performed the ground work but, due to lack of funds, these projects were abandoned. At present Subject is still connected, although indirectly, with REDCAP and CE operations. Reports from the field by Subject's case officers speak well of his capabilities, motivation, and suitability for intelligence work.

b. Future services

If this request is approved, Subject will be employed as an interrogation specialist by the Assessment and Recruitment Section of the SR Domestic Operations Base in this country. It is felt that his immigration to the United States is desirable to assure his valuable services indefinitely and to secure his continued allegiance to American interests.

3. SR/DOB is committed to employing this individual for a period of at least 6 (six) months and facilities, personnel, and funds as authorized under Project ABACRE are adequate to assume this responsibility. If, at the end of this period, SR/DOB no longer requires the services of the individual, the Office of Operations will then be requested to assume primary responsibility.

4. A detailed justification for Subject's admission to the United States, plus biographic details of him, his wife, and his daughter, are attached.

4. After a full briefing of subject and development of his capabilities, it is intended that he be used in the United States in connection with potential and assassin activities of W/COM. He will remain on the State's payroll on a contract basis until it becomes necessary to terminate his services with the Agency at some future date, it is not felt that a disposal problem will occur. His native intelligence, education and natural abilities are such that no difficulty is expected in finding him suitable employment.

5. As has been indicated, his further presence in Europe constitutes a security threat to the CIA and COMINT personnel with whom he has worked in Vienna. His attraction to the United States is therefore desirable to eliminate this potential security breach. The admission of his wife and daughter is desirable on the same grounds. They are his only close relatives in the West and their accompanying him would eliminate the opportunity for certain intelligence to recruit subject's wife and to control him through her.
