Horia SIMA, then a junior commander of the Legion, by Royal Decree (given by ANTONESCU) was made 'Commander of the Legionary Movement'. SIMA in March 1940, then acting as courier of the 'Forum', had fallen in CAROL's hands. During CAROL's reign he mysteriously had been nominated first sub-secretary and later secretary of state for education. The nomination of SIMA caused considerable confusion, especially with the rank and file of the Legion."...</p> <p>"Page 23..."</p> <p>Mihai ANTONESCU, ¹⁹⁴¹ then foreign minister (and a permanent informer of the German Embassy from times before General ANTONESCU came to power) succeeded SIMA as vice-premier.</p> <p>Legionary functionaries (mostly members of the 'Forum') with the exception of SIMA and his personal followers, during their participation in the ANTONESCU government had increasingly resisted excessive German interference into Rumanian internal affairs and economics."...</p> | | | |

The long-existing split within the Legion became evident in 1943. SIMA was expelled by the 'Forum'. The 'Forum' had authorized MANIU to act on their behalf."...

"Infuriated HITLER tried to make 'mothballed' legionaries, then still in his concentration camps, form a 'National Government' where to SIMA and his personal followers agreed whereas the 'Forum' members renounced. This puppet government is first set up in Vienna's Hotel Imperial, where SIMA acts as premier and creates many of his followers high-ranking legionaries and army Officers, it finally winds up in Alt-Aussee in May 1945."...
