37. Subject is an old friend of [redacted]'s, P/A, wife, who introduced him to [redacted]. The latter then decided to utilize Subject with DTLINEN.

38. NA. Subject is not in contact with KUBARK Case Officer.

39. Financial. Subject has an SS background, which is not apt to make him friendly to Communism.

40. POB - EGLA-11685; Frankfurt - EGQA-54374; CIC - EGQA-55029; Local MID trace negative; local CIC - reported that Identity 1 is a convinced Nazi who turned democratic, well known to DTLINEN, maintains intensive connections with the Arbeitsgemeinschaft demokratischer Kreise in Bonn. This information was received in an unsigned letter; otherwise no trace. POC granted per EGQW-21719.

41. Subject is strong willed individual and [redacted] has some trouble keeping him under complete control. However, in the past year his salary has been paid by DTLINEN and Subject has shown himself responsive to financial control.

42. For German organization, but Subject must be presumed to be aware of KUBARK interest in and support of DTLINEN.

43. None

44. Subject does not furnish information. He is the supervisor of the DTLINEN Goettingen office which sponsor rallies, speeches, etc. in the border area along the Fedrep/Soviet Zone border.
