1. INFO FROM MADRID CONFIRMS FACT SKORZENY'S INTRICUING AGAINST FORMER GENERALS AND INDICATES BITTERNESS BETWEEN DOERR AND SKORZENY RAPIDLY DEVELOPING PUBLIC FEUD. HAVE NO DOUBT UTILITY WILL INTEREST HIMSELF THIS AFFAIR WHILE MADRID.

2. VIEW POSSIBILITY UNFAVORABLE PUBLICITY BREAK AS RESULT SKORZENY'S MANEUVERING CONSIDER IMPORTANT WE CLARIFY OUR INTERESTS AND ANY U.S. CONNECTIONS FULLY. CAN YOU EXPLAIN ZIPPER CLAIMS MGLA-5813 AND 5882 SKORZENY CONNECTED WITH OR SUPPORTED BY U.S. COLONEL THOMPSON OR STIMPSON. VIEW CATEGORICAL DENIAL RGRHYTHM INTEREST IS IT POSSIBLE CIC IS THE U.S. INTEREST IF ANY BEHIND SKORZENY? NOTE SERVERIN WALLACH CIC BERLIN HAS USED ALIAS COLONEL THOMPSON. PLS CHECK THROUGH STUTTGART AND DIRECTLY BERLIN RE PARA 1A REFERENCE.
